

A RESOLUTION OF THE BOARD OF DIRECTORS

2. Tony Graf - **Zone 6**
3. Vacant (no candidate) - **Zone 8**


The Board of Directors declares the above-named candidates elected to the positions indicated. The election for those offices shall not be held.
